## **About The American University in Cairo:**

Founded in 1919, AUC moved to a new 270-acre state-of-the-art campus in New Cairo in 2008. The University also operates in its historic downtown facilities, offering cultural events, graduate classes, and continuing education. Student housing is available in New Cairo. The successful applicant will hold a terminal degree in Law (e.g. J.D./S.J.D./Ph.D. in Law) by the date of appointment. The successful applicant will possess expertise in Comparative Law.
