- Re-design the blog to enhance its capacity to host videos with direct link to our YouTube Channel.
- Establishing new pages on the blog and in particular for the African Sovereign Debt Justice Network
- Performing requirements analysis and writing design specifications.
- Analyzing and troubleshooting software problems, broken links and providing solutions to overcome those problems using web-based technologies.
- Working with third parties to meet the technical needs for assigned projects
- Reviewing web site for adherence of organization specifications and standards
- Performing related duties as required or assigned
- Developing and designing presentations and graphic communications
- Ensuring the new web design gives prominence to the African Sovereign Debt Justice Network activities.

Qualifications:
